Delaware River Stage Company – offers variety shows (The Christmas Show). They are funded by ticket sales and donations. They donate their "profit" to the Walton Theater Preservation Association.

Walton Theater Preservation Association – raises funds by donation for restoration projects in the Theater.

R.S.S. – rents the Theater from the Village to run a movie theater.

Trustee Gregory made a motion to amend the rental agreement with R.S.S. to include the museum room for an additional \$25.00 a month. No second. The Mayor recommended preparing a new, up-dated lease for approval at the next Board meeting.
