FORECLOSURE PROCESS The Clerk submitted a listing to the Board of all outstanding taxes. After discussion, Trustee Sehen made a motion to authorize Attorney Merzig to start the foreclosure process for any and all tax liens per statutory period set by the New York State Real Property Tax Law. POLICE VEHICLE The Chief submitted a request for a new vehicle with budgetary funds from personal services. After discussion, Trustee Jamieson made a motion to authorize Chief D’Addezio to order a Police Vehicle from Van Bortel Ford at a cost of \$33,228.47 and outfitting from Bush Electronic for \$6,770.00 both from A3120.200, the police sedan will cycle down to the Code Officer and the Impala will be sold. Trustee Doig seconded. Carried unanimously.

POOL CHEMICALS The Village has been notified by our chemical suppliers that there is a shortage of chlorine. Due to this notification the Board discussed if the pool should open. It was decided the pool would open on Monday, June 27th and run until our chemicals run out.

EXECUTIVE SESSION Trustee Doig made a motion to enter Executive Session to discuss Police Contract negotiations at 2:22 p.m. Trustee Jamieson seconded. Carried unanimously.
